# LIFETIME FLOORS Thin Stamp Overlays

# Description

LifeTime Floors (LTF) Thin Stamp Overlay is a twocomponent polymer modified cementious stampable overlay. When applied in conjunction with color, stains and sealers, it produces a decorative paving finish similar to imprinted concrete. Typically applied at ¼ - to 3/8 inch thickness, LTF Thin Stamp Overlay can be used interior and exterior, residential, commercial, municipal, and industrial construction. It's very high compression strength and can be left exposed to traffic; regular maintenance is recommended. Most imprinting tools can be used with LTF Thin Stamp Overlays.

#### Yield

Approximate coverage is as follows:

# **Packaging**

50 lb (25 kg) multi-wall bags

#### Color

Gray or white base

#### **Shelf Life**

18 months when properly stored

#### Storage

Store unopened packaging in a clean, dry area protected from sunlight at 50-90°F (10 to 32°).

Tint packs can be added to integrally color the material before application

# How to Apply Surface Preparation

- 1. Perform surface preparation in compliance with ICRI Technical Guideline No. 03732 "Selecting and Specifying Concrete Surface Preparation for Sealer, Coatings and Overlays." CSP 2-3 profile.
- 2. Remove all deteriorated concrete. Substrate should be free of dirt, oil and contaminants. Roughen the surface by mechanical methods such as sandblasting, shot blasting or other suitable means. Do not use a method of surface preparation that will fracture the concrete.

- 3. Fill, repair and level any damaged areas deeper than ½ inch before topping application.
- 4. Apply LTF Thin Stamp Overlay primer to clean, dry concrete.
- 5. Honor any expansion joints and saw cuts with metal stripping or control joints.

#### Mixing

- 1. In mixing tub, pour half of the LTF Multi Purpose liquid mix. Stir. (Include bottom)
- 2. Add Tint pack to mixing tub. Mix3 minutes or until dispersed evenly
- 3. Add one gallon of tinted liquid with 50 lb bag of Thin Stamp Overlay. Mix together
- 4. After mixing is free of lumps, apply Thin Stamp Overlay mix immediately. Working time is approximately 30-60 minutes depending on humidity.

# Application Steps Liquid Primer

Dilute LTF Thin Stamp Overlay mix 1-1 (50%) with clean, cool water to make liquid primer.

With Pump-up sprayer, paint roller or brush, apply primer to 150-250 sq.ft per gallon.



#### **Body Coat**

While primer remains tacky, apply body coat. Spread mix and strike only one or two times. Do not overwork surface. Imprinting tools will eliminate surface imperfections.

## **Imprinting**

- 1. Allow LTF Thin Stamp Overlay mix to cure. Press finger into mix. If finger leaves imprint without material sticking to them, proceed.
- 2. Apply liquid release to imprinting tools and onto the surface.

## Stamping

- 1. Align and lay stamps into materials.
- 2. Imprinting tools with skinny joint profiles and 45-degree relief edges work best.
- 3. Smaller aggregates require less aggressive manipulations. Gentle malleting is necessary.
- 4. Gently lift both edges to relieve suction between surface and tool. Use proper tools for handling and edge cleaning.

### **Staining and Sealing**

For antiquing, staining, and coloration treatments, follow appropriate application guidelines. Choose sealers best suited for application, traffic, use, maintenance and exposure. It is best to wait 1 day before staining and sealing.

# **Clear Sealer**

Apply sealer by sprayer, brush or roller.

# **For Best Performance**

- Materials must be stored and mixed at temperatures of 65-80°F (18-26°C).
- Never apply LTF Thin Stamp Overlay mix below 55°F and never allow product to freeze.
- All curing agents, sealers and hardeners must be removed from concrete prior to primer application. Prep using mechanical shot blasting, grinding or power scarifying.
- Be sure to use all the provided polymer resins. Scrape hardener from container.
- Do not turn mixing vessels upside down to drain on flooring surface.
- Keep unfinished flooring surface clean.
- Do not track dirt, grease, and other contaminants onto unfinished flooring.
- Good ventilation must be provided during application.
- Always obtain, read and observe Manufacturer's Safety Data Sheet before handling.
- This application is not designed to bridge cracks, working joints, dynamic cracks or expansion joints.
